## Introduction to Universal Credit and Health Support

Purpose of Universal Credit to support individuals with low income, unemployment or health related work limitations through monthly payments

Consolidation of Benefits - UC combines multiple legacy benefits

Digital Access with Support -Claimants can apply and manage their UC account online, support is available to assist people who need it Tailored Support for Health Conditions - UC provides adjustments and additional payments to assist claimants with health conditions, disabilities and/or limited work capability

# The role of Disability Employment Advisors (DEAs)







Coaching and upskilling

Employers and Partnerships Direct Support

## **DEA Direct Support**

Up to 13 weeks 1:1 support to move towards work

CV support, interview preparation, mock interviews, confidence building

Explaining reasonable adjustments, use of health adjustment passport to identify reasonable adjustments

Signposting to internal and external provision

Supporting claimants to find Disability Confident Employers

Promoting the Access to Work scheme for support beyond reasonable adjustments

## Universal Credit Health Journey

**Day 1:** Claimant reports health condition (self-certify for 7 days).

Day 8-14: Fit note required - all work-related requirements switched off.

Day 15+: Work preparation/search may restart but tailored to health needs. Claimant must continue to provide fit notes whilst they are unfit for work

**Day 29:** Referral for Work Capability Assessment (WCA) to determine their level of work capability

## Work Capability Assessment (WCA)

- Claimant will be sent a UC50 Health Questionnaire form to complete and return
- Medical assessment in person/virtual/telephone

### 3 Outcomes

Fit for work

Limited Capability for Work (LCW) - some work preparation tasks

Limited Capability for Work and Work-Related Activity - No work requirements, extra UC payments and Work Allowance

## What happens next

- ▶ If a claimant is found to be Fit for Work, this means they have been deemed capable of doing some type of work, this might be part time or full time. They can have another WCA if their condition has worsened or if they develop a new health condition.
- ► They will engage with a Work Coach and DEA if needed to support them into work they can do.
- ▶ If a claimant has LCW they will be expected to complete work preparations activities and engage with their work coach, but on a less frequent basis.
- ▶ If a claimant has LCWRA they will not be assigned a work coach or be expected to search or prepare for work, unless they request support to do so.

For the patient – what to do now Please read the notes below then fill in your details and, if you are claiming social security benefits, sign and date the declaration. If you cannot fill in your details yourself, ask someone else to do it for you.

### What your doctor's advice means

Not fit for work: Your doctor will advise this when they believe that your health condition means you should refrain from work for the stated period of time.

May be fit for work taking account of the following advice:
Your doctor will recommend this when they believe that you may be able to return to work with some support from your employer. Sometimes it may not be possible for your employer to act on the doctor's advice and you will not be able to return to work until you have further recovered. You do not need to get a further Statement from your doctor to confirm this.

If you are employed
If you are not fit for work, or your employer cannot support your return to work, your employer should consider paying Statutory Sick Pay (SSP) based on the information provided.

If SSP cannot be paid, or your SSP is ending, your employer will give you form SSP1 to claim social security benefits. If you are self-employed, you may be able to claim social security benefits because of your health condition.

Social security benefit claimants
If you are claiming social security benefits because of your health condition, send this form to your Jobcentre Plus office. If you are claiming social security benefits for any other reason, you should contact a Personal Adviser to discuss the advice on the form. If you do any work you must inform Jobcentre Plus of your change of circumstances.
